Michael Batty said, in the New Science of Cities, that we must not simply understand a city as a place in space, but rather a system consisting of network and flow. The network refers to the link between various elements of the urban system, and the flow represents the strength of the connection between locations. Batty believes that to understand space, we must understand the flow, to understand the flow, we must understand the network. Batty also draws on the theories of complexity science, social physics, urban economics, transportation theory, regional science and urban geography to propose theories and methods to reveal the deep structure of urban operation. Batty examined the size of the city, the internal order, the characteristic traffic routes, the location of the tectonic network, etc., and introduced simulation methods from the simple stochastic model to the bottom-up evolution model to the integrated model of traffic and land use. Using these theories and methods, he proposed a design and decision model to predict the future interaction and flow of the city. 



China Energy Modeling Forum (CEMF)

2015 年,由清华大学产业发展与环境治理研究中心(CIDEG)与美国环保协会(EDF)共同 发起成立中国能源模型论坛(CEMF),旨在为国内外能源、经济、环境和人类健康模型队提 供对话互动和观点交流的平台,为决策者和其他群体理解各类模型创造机会,共同推动中国能源与环境模型的能力建设,提升中国能源、环境与经济领域的科学决策水平。

CEMF 每年邀请不同的模型团队和技术人员定期举办技术交流会,针对决策情景、不同模型 和结果进行讨论。截止到 2019 年已参加 CEMF 平台的交流、培训的模型技术人员达到 1000 余人。

The China Energy Modeling Forum (CEMF), jointly initiated by the Center for Industrial Development and Environmental Governance (CIDEG) at Tsinghua University and Environmental Defense Fund (EDF), is a platform for domestic and international modeling professionals working in energy, economic development, environment, human health and climate change fields to exchange and refine modeling ideas—and for non-technical policymakers and investors to improve their understanding of the strengths and weaknesses of different models in different applications. It aims to enhance capacity building of Chinese modeling teams, increase credibility of models and strengthen scientific policy development and decision making in the fields of environment, energy and economy.







From the perspective of policy process, this paper scrutinizes 64 national voluntary reports which were presented at the High Level Political Forum (HLPF) in 2016 and 2017. In particular, four implementation modes have been distinguished: government-led implementation, society-led implementation, collaborated implementation, and implementation failure.

The paper claimed that the burden of social insurance payment Chinese enterprises bearing is overwhelming. The specific actions are as following: easing the burden of companies and encouraging efficient investment; increasing citizens' disposable income; improving endowment insurance system; motivating healthy development of capital market; transferring national asset to social insurance and promoting the reform of stateowned companies, etc.

This paper mentioned that with the change of international situation and country's own developing phase, economic development in China experienced severe challenges confronting the declining of traditional incentives when the globe were against the "wind". In order to achieve long-term sustainable economic development, China should satisfy the requirements of "Chenery theory" which are necessary for self development. Specifically, insisting on depening reform, expanding opening-up policy, leading the process of globalization and maintaining the tolerance to the world are right ways to meet the above requirements.

2019 年 4 月,CIDEG 博士后、洪堡学者关婷,清华大学文科资深教授、苏世民书院院长、CIDEG 主任薛澜与清华大学公共管理学院副教授、CIDEG 主任助理赵静合作发表论文《技术赋能的治理创新:基于中国环境领域的实践案例》。论文结合治理理论前沿与中国治理创新生化实践,提出"技术赋能的治理创新模式",认为技术赋能实践正在成为构建多元互动关系和优化治理结构的新型驱动力。通过对两个环境领域案例的剖析,本文发现,技术赋能创新正在形成一套以应用为基础的社会问题解决机制,通过降低信息不对称提升治理水平。

In April 2019, post-doctoral researcher of CIDEG and Humboldt fellow Guan Ting, director of CIDEG, Dean of Schwarzman College and Distinguished Professor of Arts, Humanities and Social Sciences, Tsinghua University Xue Lan. director assistant of CIDEG and associate professor of SPPM, Tsinghua University Zhao Jing jointly published "Technology-enabled Governance Innovation: An Empirical Study of China's Environmental Action" on Chinese Public Administration. Based on governance theory and China's innovation practices, this paper proposes the framework of "technology-enabled governance innovation" and argue that technology-enabled innovation is becoming a new driving force for transforming governance mode. Analyzing two typical cases in the environmental field, this paper suggests that a new problem-solving mechanism, aiming in reducing information asymmetry, is emerging.

In April 2019, member of CIDEG Academic Committee, professor of Department of Innovation, Entrepreneurship and Strategy in Tsinghua SEM Chen Jin published "Open Innovation in Gig Economy" on *Technology Economics*. Based on the review of literature in open innovation and knowledge management, this paper believes factors for successful coordinating gig innovations include communication with the outside community in all parts of the innovation process, equipment of formal and clear roadmap, links among cross boarder departments, atmosphere of self-driven employee, top-level strategies' emphasis and support on open innovation.

In June 2019, Takeo Hoshi, Professor of Finance, by courtesy, Graduate School of Business, Stanford University and Joint Chairman, Academic Committee of CIDEG published "Potential for Inward Foreign Direct Investment in Japan" on NO.52 Journal of the Japanese and International Economies. The paper estimates a gravity model of bilateral FDIs using data for 35 OECD countries as destination countries. This model includes lorigin and destination) country-specific effects as well as destination-country specific time trends.

China Sport Science | Jiang Xiaojuan: Development of Sports Industry: New Opportunities and Challenges

In July 2019, member of CIDEG academic committee, Dean of SPPM, Tsinghua University Jiang Xiaojuan published "Development of Sports Industry: New Opportunities and Challenges" on China Sport Science. The paper summarizes "eight new changes" which have happened on the development environment of Chinese sports industry over the last five years, including development concept, development level, urbanization, aging, technology application, strategic investors, media broadcasters and educational concepts. The paper also analyses "four new challenges", namely, the emergence of new sports events, multicomponent entertainment programs, the decline of profession and concentration, and the constraints of total consumption time. At the same time, this paper supposes "three new ideas" to react to the changes and challenges, namely, continuous innovation, acceptance of new sports forms, and better role of the government.

In August 2019, Xue Lan, director of CIDEG, Dean of Schwarzman College and Distinguished Professor of Arts, Humanities and Social Sciences, director assistant of CIDEG, Tsinghua University and Zhao Jing, associate professor of SPPM jointly published "Toward Agile Governance: The Pattern of Emerging Industry Development and Regulation" on *Chinese Public Administration*. This paper points out the core of agile governance for emerging industry is to match the institutional resources with the development of the industry, which should be different from the traditional governance framework in governance principles, governance relations and governance tools, so as to achieve the organic balance of the core objectives of governance. Finally, this paper raises three optimized paths for emerging industries to move towards agile governance.

In August 2019, Professor of SPPM, Director of Institute of Philanthropy and NGO Center of Tsinghua University Wang Ming published "the Origin of Publicity and the Border of Right of Plural Subjects under the Structure of Co-construction, Co-governance and Co-sharing on Governance. Co-construction, co-governance and co-sharing explain the fundamental requirements of social governing from the perspectives of resource integration, governing process and progress sharing, respectively. Specifically, co-construction emphasizes cooperation of labor and capital, co-governance emphasizes cooperation of intelligence and work, and co-sharing emphasizes common interests and success. The core is around doing things together, which highlights the publicity of social governance.

In September 2019, member of CIDEG Academic Committee and vice president of China Academy of Social Science, Cai Fang published "From Comparative Advantage to Economies of Scale-Recognition of Northeast Economy" on Study and Exploration. This paper claims that regional development imbalance still exists, and a series of new characteristics have appeared. So balanced development strategies now confront new challenges. In the past rounds of revitalizing northeast China, northeast region is ought to seize the opportunities to update manufactural industry and improve its position in value chain. Furthermore, the region should also take advantage of its economies of scale to improve the business environment and resources distribution mechanism. By these ways can northeast region realize its goal of becoming the new growth point of high quality economic development in China.
