# 中心简介

#### **ABOUT CIDEG**

2005 年 9 月,在清华大学公共管理学院首任院长陈清泰与著名经济学家青木昌彦教授、吴敬琏先生等众多国内外著名学者的筹划下,由日本丰田汽车公司提供无偿资助,成立清华大学产业发展与环境治理研究中心(CIDEG)。

CIDEG 定位于产业发展、环境治理与制度变迁领域的政策研究和学术交流,旨在提高中国公共政策与治理的研究与教育水平,促进学术界、产业界、非政府组织及政府部门之间的沟通、理解和协调。







The project studies the position and role of hydrogen energy in China's low-carbon energy transition from a macro perspective and conducts a full lifecycle evaluation on hydrogen cell-powered vehicles at the industrial level, particularly the transportation sector. In combination of typical hydrogen energy pilot demonstration area case studies, the project provides the research basis for China's hydrogen energy development strategy and industrial policies.

课题主要研究环境质量改善对人力资本积累的影响。 综述环境质量与人力资本积累之间的关系,利用自中国 "向污染宣战"以来显著的空气质量的改善,定量分析 其对人群健康和人力资本积累的影响。利用中国疾病预 防与控制中心的人群健康的大数据,通过对比环境质量 改善较大的地区和较小的地区在政策改变前后的变化, 估计空气质量提高对人群健康与人力资本积累的影响。 借鉴和对比不同国家不同历史时期环境保护政策的变化, 寻找适合中国目前国情与政策目标的环保政策,以提高 人力资本质量。

The project mainly studies the impacts of environmental improvement on the accumulation of human capital. It gives an overview of the relationship between environmental qualities and the accumulation of human capital and conducts an quantitative analysis on the impacts of population health and the accumulation of human capital brought by marked air quality improvements since China "declared the war on pollution". Using big data on population health collected by the Chinese Center for Disease Control and Prevention, the study compares data in regions with much improved environmental qualities against little improved environmental qualities in periods before and after policies were implemented and provides an estimation of the impacts on population health and the accumulation of human capital brought by the improvements of air quality. ## 全球科技创新中心指数 2020 GLOBAL INNOVATION HUBS INDEX (GIHI) 2020

2020年9月,清华大学产业发展与环境治理研究中心(CIDEG)与施普林格·自然(NATURE)合作,首次面向全球发布《全球科技创新中心指数2020》(Global Innovation Hubs Index, GIHI)。

《全球科技创新中心指数 2020》研究负责人为清华大学产业发展与环境治理研究中心陈玲。指数紧紧围绕全球科技创新中心的核心功能与内涵,通过客观数据呈现出不同城市在关键指标上的排名,探索创新变革的力量、关键要素和条件,展现出城市参与经济全球化过程中的必要准备与核心竞争力。指数在全球范围内研究遴选出 30 个城市(都市圈)作为评估对象,构建了由科学中心、创新高地、创新生态 3 个一级指标以及 12 个二级指标和 31 个三级指标构成的指标体系,系统反映了全球主要科技创新中心城市(都市圈)的综合创新能力和水平。

2020年9月19日,在2020中关村论坛上,施普林格·自然大中华区总裁安诺杰(Arnout Jacobs)先生和清华大学产业发展与环境治理研究中心学术委员会联席主席薛澜教授共同面向全球发布了《全球科技创新中心指数2020》(Global Innovation Hubs Index, GIHI)。

In September 2020, the Center for Industrial Development and Environmental Governance (CIDEG) at Tsinghua University, in collaboration with Springer Nature, released the Global Innovation Hubs Index (GIHI) 2020 for the first time to the outside world.

The GIHI 2020 assessment project has been led by Chen Ling from the Center for Industrial Development and Environmental Governance at Tsinghua University. By focuses on the essential functions of global innovation hubs, the Index system presents the ranking of different cities on key indicators supported by objective data, the assessment project aims to identify the different forces. key elements and enablers driving the dynamics of innovation, and highlights the essential building blocks and core competitive advantages of cities in the course of economic globalization. The research team screened and selected 30 cities (metropolitan areas) from around the world for in-depth assessment, and developed an index system consisted of three primary indicators, namely, science centers, innovation hubs and innovation ecosystem, as well as 12 secondary indicators and 31 tertiary indicators, to systematically reflect the comprehensive innovation capability and the caliber of the leading global science and technology innovation hubs (metropolitan areas).

On September 19, 2020, Mr. Arnout Jacobs, President of Springer Nature for Greater China, and Professor XUE Lan, Co-Chair of the Academic Committee of the Center for Industrial Development and Environmental Governance at Tsinghua University, jointly released the Global Innovation Hubs Index 2020 [GIHI 2020] at the 2020 ZGC Forum.

Why do some cities grow economically while others decline? Why do some show sustained economic performance while others cycle up and down? In Keys to the City, Michael Storper, one of the world's leading economic geographers, looks at why we should consider economic development issues within a regional context—at the level of the city-region—and why city economies develop unequally. Storper identifies four contexts that shape urban economic development: economic, institutional, innovational and interactional, and political. The book explores how these contexts operate and how they interact, leading to developmental success in some regions and failure in others. Demonstrating that the global economy is increasingly driven by its major cities, the keys to the city are the keys to global development. In his conclusion, Storper specifies eight rules of economic development targeted at policymakers. Keys to the City explains why economists, sociologists, and political scientists should take geography seriously.

本书为著名经济史学家乔尔·莫克尔的大作,聚焦于英国光荣革命到水晶宫展览期间思想和制度对经济快速发展的重要作用。莫克尔认为,如果认识不到英国启蒙时期知识变化的重要性,我们不可能很好地理解工业革命。与传统的标准解释,比如地理决定论,市场、政治和社会的作用等不同,莫克尔认为,英国现代经济的增长很大程度上是源于核心人物的认知和信念,以及这些信念对经济行为的影响。他认为,之所以是英国引领其他欧洲国家进入工业革命,是因为英国是思想、文化、制度和技术的最佳交汇处,因此引领了经济发展。

This book focuses on the importance of ideological and institutional factors in the rapid development of the British economy during the years between the Glorious Revolution and the Crystal Palace Exhibition. Joel Mokyr shows that we cannot understand the Industrial Revolution without recognizing the importance of the intellectual sea changes of Britain's Age of Enlightenment.

In a vigorous discussion, Mokyr goes beyond the standard explanations that credit geographical factors, the role of markets, politics, and society to show that the beginnings of modern economic growth in Britain depended a great deal on what key players knew and believed, and how those beliefs affected their economic behavior. He argues that Britain led the rest of Europe into the Industrial Revolution because it was there that the optimal intersection of ideas, culture, institutions, and technology existed to make rapid economic growth achievable.



SUMMER INSTITUTE FOR CHINA'S GREEN INNOVATORS (SICGI)





中国绿色创新夏季学院(SICGI)由清华大学和 Apple 共同发起成立,为培养新一代环保创新人才和青年领袖,以迎接绿色转型和新一代技术革命的挑战。中国绿色创新夏季学院自 2016年成立以来已成功举办五期培训活动和绿色创新大赛,项目由清华大学产业发展与环境治理研究中心承办。

The Summer Institute for China's Green Innovators (SICGI) was jointly sponsored by Tsinghua University and Apple and organized by CIDEG in a bid to train the new generation of environmental innovators and young leaders to embrace the green transition and to tackle the challenges of the next technological revolution. Since its launch in 2016, SICGI has held 5 training programs and Green Innovation Competitions.

从 2016 年-2019 年,已连续举办 5 期 "中国绿色创新夏季学院"培训,共计培养来自全国高校的学生 180 余人,形成 59 项环保创新方案。

突如其来的新冠疫情给学习和生活都带来了诸多困难和挑战。经过层层选拔,SICGI2020 特别训练营云端集结了来自全国各地共 43 名优秀的环保青年,他们分别来自清华大学、北京大学、武汉大学、华中科技大学、中山大学、复旦大学、上海交通大学、南京大学、滑铁卢大学等国内外著名高校。通过清华大学学堂在线,完成了 48 学时的《绿色创新理论与实践》课程,聆听了来自生态环境部门、企业、高校、环境公益组织等领域专家的 26 场在线主题讲座,并与北京、上海、江苏、浙江、湖南、福建等地的实务工作者进行了 30 余次 " 云访谈 "。

Between 2016 and 2019, 5 consecutive SICGI training programs have been held. Over 180 students from higher education institutions from around the nation had joined the training programs and created 59 innovative environmental protection solutions.

The coronavirus pandemic has brought abrupt difficulties and challenges to our academic routines and life in general. After a series of enrollment processes, 43 outstanding young environmentally minded students are selected from around the country to join the SICGI 2020 Special Training Camp remotely. They are all from renowned Chinese and overseas universities, including: Tsinghua University, Peking University, Wuhan University, Huazhong University of Science and Technology, Sun Yat-Sen University, Fudan University, Shanghai Jiao Tong University, Nanjing University and The University of Waterloo, etc. The students, via Tsinghua Xuetang (online course platform), completed 48 class hours of course contents titled "Green Innovation: New Theories and Practices". They also heard from multiple experts from different fields: ecology and environment agencies, businesses, higher education institutions as well as environmental non-profit organizations in 26 online lectures and held over 30 cloud-based interview discussions with field practitioners from Beijing, Shanghai, Jiangsu, Zheijang, Hunan and Fuijan, etc.

## 中国能源模型论坛

**CHINA ENERGY MODELING FORUM (CEMF)** 



2015年,由清华大学产业发展与环境治理研究中心(CIDEG)与美国环保协会(EDF)共同发起成立中国能源模型论坛(CEMF),旨在为国内外能源、经济、环境和人类健康模型团队提供对话互动和观点交流的平台,为决策者和其他群体理解各类模型创造机会,共同推动中国能源与环境模型的能力建设,提升中国能源、环境与经济领域的科学决策水平。

CEMF 每年邀请不同的模型团队和技术人员定期举办技术交流会,针对决策情景、不同模型和结果进行讨论。论坛成立至今,已经吸引 100 多家国内外高校、国际机构、行业研究机构、智库等超过1000 多名研究人员的参与,是中国能源模型领域最具影响力的论坛组织。

In 2015, China Energy Modelling Forum (CEMF) was jointly initiated by CIDEG and the Environmental Defense Fund (EDF), aiming to serve as a platform of interactive dialogues and exchanges for Chinese and international modelling teams in the fields of energy, economy, environment and healthcare. The Forum also facilitates policy makers and other groups to better understand various types of models in a bid to bolster China's energy and environment modelling capacity and to improve the science-based decisionmaking process for China's energy and environment policies.

Each year, CEMF invites different modelling teams and technical members for discussions on decision scenarios, different models and results at regular technical seminars. Since the Forum's inauguration, more than 1000 researchers from over 100 Chinese and overseas higher education institutions, international organizations, industrial research organizations and thinktanks have participated in these events, making CEMF the most influential forum in China's energy modelling field.

## 论坛主要研究成果

Forum main research results

## CEMF 01: 中国碳排放峰值的多模型比较研究

CEMF 01: Multi-model Comparative Study of China's Carbon Emission Peak

在巴黎气候变化大会上,我国政府提出了"2030年左右碳排放达峰,并争取尽早实现","2030年单位 GDP碳排放比2005年下降60-65%"和"2030年非化石能源占比20%左右"等一系列目标,对经济新常态下制定能源转型、应对气候变化和低碳发展政策意义重大,同时也面临着来自经济增长、能源资源约束以及环境治理等多重考验。

CEMF 01 旨在降低碳排放峰值研究的不确定性,并探索出最具成本有效性的发展路径。其中,选择合适的模型进行比较分析,是本主题研究的核心内容。经过两年的研究,围绕碳排放达峰,CEMF 01 完成了 9 个研究报告,并在《气候变化进程》英文版发表多篇重要论文。

At the UN Conference on Climate Change in Paris, the Chinese government set a series of goals: "the country's carbon emission level would peak around 2030 and we will strive to achieve the goal as early as possible", "carbon emission per unit of 6DP to be reduced by 60-65% comparing to 2005 level", "non-fossil fuel to account for around 20% of total energy consumption". These goals are profound for policy making concerning energy transition, tackling climate change and low-carbon development under the new economic normal. At the same time, they are also under great test by pressure from economic development, energy resource constraints and environmental governance.

CEMF 01 aims to reduce the uncertainty in the research work of studying carbon emission peak and to identify the most cost-effective pathway. The core of the project is the selection and comparison of suitable models. After 2 years of research efforts, CEMF 01 has concluded 9 research reports with regards to carbon emission peak and has published numerous key papers in Advances in Climate Change Research (English version).

## CEMF 02: 中国 2050 低排放发展战略研究

CEMF 02: Research on China's 2050 Low Carbon Emission Development Strategies

《巴黎协定》邀请所有缔约方在 2020 年前提交长期温室气体低排放发展战略。习近平主席在十九大报告指出:加快生态文明体制改革,建设美丽中国。到 2035 年,生态环境根本好转,美丽中国目标基本实现;到本世纪中叶,把我国建设成富强民主文明和谐美丽的社会主义现代化强国。

CEMF 02 旨在运用并比较多种不同的能源、经济、环境模型,以十三五、十四五的近中期发展目标为实践节点,并探讨到 2050 年的低温室气体(包括非二氧化碳温室气体)排放发展的长期目标,构建符合中国技术的政策要求的低排放发展路径。

The Paris Agreement has invited all State Parties to submit their long-term low greenhouse gas emissions strategies. President Xi Jinping has said in the report of the 19<sup>th</sup> CPC National Congress that "the reform on ecological civilization institutions will be accelerated to build a beautiful China. By 2035, the ecological environment will be fundamentally improved and the targets of the Beautiful China Initiative will be met; by the middle of the century, we will develop China into a great modern socialist country that is prosperous, strong, democratic, culturally advanced, harmonious, and beautiful".

CEMF 02 aims to use and compare various energy, economic and environmental models and identify, based on the short to mid-term targets set out in the 13<sup>th</sup> &14<sup>th</sup> Five Year Plans, long-term targets for low greenhouse gas emissions(including non-C02 greenhouse gases) development in order to build a low emission development pathway that will meet China's technical and policy requirements

## CEMF 03: 2035 低碳发展与美丽中国目标 CEMF 03: 2035 Low Carbon Growth and Beautiful China Targets

2020年9月22日,习近平第七十五届联合国大会一般性辩论上的讲话中宣布"中国将努力争取2060年前实现碳中和"。为了进一步推动中国早日实现碳中和目标,CEMF03将以"2035低碳发展与美丽中国目标"为主题,旨在链接2035美丽中国目标和全球气候环境与可持续发展目标的通道,搭建2035美丽中国目标与2030可持续发展目标、及2060中国实现碳中和目标的桥梁,推动"一带一路"建设,引领全球生态文明建设,构建人类命运共同体,进而实现美丽地球。

In President Xi Jinping's address to the 75<sup>th</sup> UN General Assembly on September 22, 2020, he declared that "China aims to achieve carbon neutrality by 2060". The project will also establish connections between the goals of the Beautiful China (by 2035) Initiative, the sustainable development agenda (by 2030) and carbon neutrality (by 2060) in order to promote the "Belt and Road Initiative", to take the lead in building the global ecological civilization, to build a community of shared future for mankind so we can make the Earth a beautiful planet.

On December 30, 2019, Chen Qingtai, former Vice Minister & Party Secretary, Research Fellow, Development

Research Center of the State Council and Honorary Advisor to CIDEG, attended the 1st China Enterprise Reform and Development Forum and delivered a keynote speech. According to Chen, in order to reinvigorate state-owned enterprises, numerous documents and policies have been issued by the government to serve two purposes: devolve more power to enterprises, and strengthen oversight. In order to draw a line between the government functions and the enterprise functions, within its administrative framework, the government has tried and failed to strike a proper balance between giving the businesses a free reign without totally losing control. For over two decades, time and again the pendulum moved from tight control to letting go of the control, never able to get rid of the persistent problem of "chaos without tight control, and tight control kills the vitality".

The key finding is that when faced with air pollution, highly motivated scientists significantly elevated the importance of scientific communication, while less motivated scientists did not change their perception of the importance of scientific communication.

# Journal of Public Management | ZHAO Jing, XUE Lan, WANG Yuzhe: New Wine in an Old Bottle: the Causes of the 2015 Stock Market Crash Viewed from the Public Policy Perspective

In April 2020, Zhao Jing, Director Assistant of CIDEG, Xue Lan, Joint Chairperson of CIDEG Academic Committee, Wang Yuzhe, Researcher of Center for Public Finance, Economy and Governance, Tsinghua University, jointly published "New Wine in an Old Bottle: the Causes of the 2015 Stock Market Crash Viewed from the Perspective of Public Policy" in the Journal of Public Management.

The paper points out that one of the key factors contributed to the 2015 stock market crash was that in reforming the capital market, scant attention was paid to the policy features of the capital market, and the reform had followed the same logic of the traditional administrative policy mechanisms, which led to deviations in policy implementation and ultimately triggered the stock market crash.

This essay demonstrates how China's domestic industrial policies provide important indirect support for the Digital Silk Road, as shown by Alibaba's activities in Malaysia.

2020年6月,星岳雄在《美国国家经济研究局工作报告》发表文章《大脱节:日本工资与通胀的脱钩》。

文章的主要发现是,日本劳动力市场动态在 1998 年后发生了转变,伴随着收入和物价之间关系的破裂,劳动力市场紧缩和收入之间的相关性也明显减弱。因此收入增长对于物价上涨已经不是一个那么重要的决定性因素。

# NBER working paper | Hoshi Takeo: The Great Disconnect - The Decoupling of Wage and Price Inflation in Japan

In June 2020, Hoshi Takeo, Joint Chairperson of CIDEG Academic Committee published "The Great Disconnect - The Decoupling of Wage and Price Inflation in Japan" in NBER Working Paper.

Our key finding is that labor market dynamics shifted after 1998 so that correlations between labor market tightness and wages weakened noticeably. This change was accompanied in a break in the relationship between wages and prices, so wage inflation has become a much less important determinant of price inflation.
